**The point(s) at which fish and fish products may enter a chain of custody:**

The main points of landing for these fisheries are all New Zealand ports. The scope of this certification ends at the points of landing which are described above. Downstream certification of the product would require appropriate certification of storage and handling facilities at these locations. Fish and fish products from the fishery may enter into further certified chains of custody and be eligible to carry the MSC ecolabel. No Inseparable or Practically Inseparable (IPI) catches are allowed under this certificate.
