The main points of landing for these fisheries are all New Zealand ports.

The scope of this certification ends at the points of landing. Downstream certification of the product would require appropriate certification of storage and handling facilities at these locations.

No Inseparable or Practically Inseparable (IPI) catches are allowed under this certificate.

The parties, or categories of parties, that are entitled to use this certificate to enter fish from the certified fishery into certified chains of custody:

The eligible parties to use the fisheries certificate are shareholders of the NZ Seafood Deepwater Council. Anyone who owns quota has the opportunity to become a DWG shareholder. Those not a part of the DWC are required to have a certificate sharing agreement.
